SECTION E CERTIFICATION

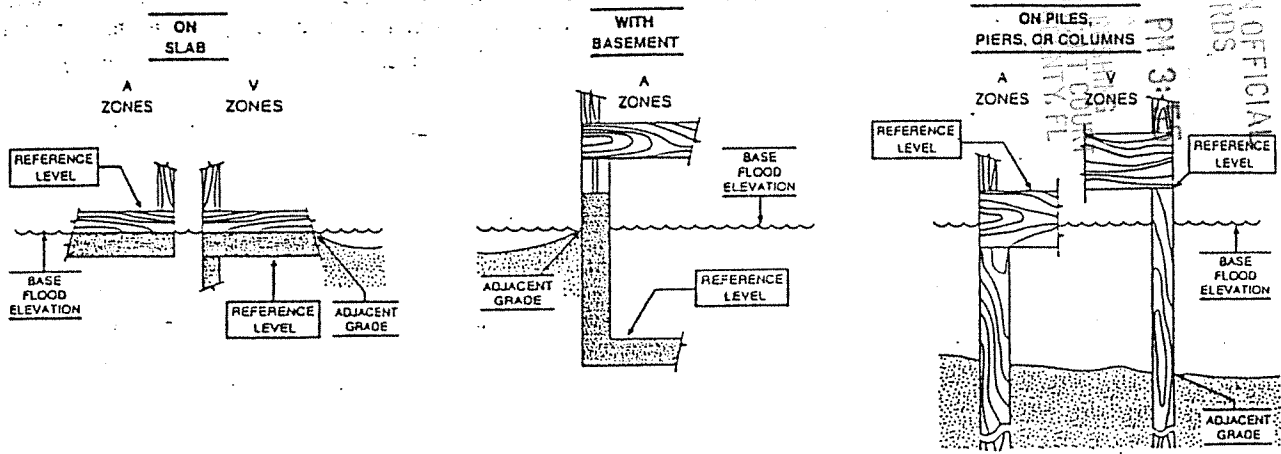
