SECTION E CERTIFICATION

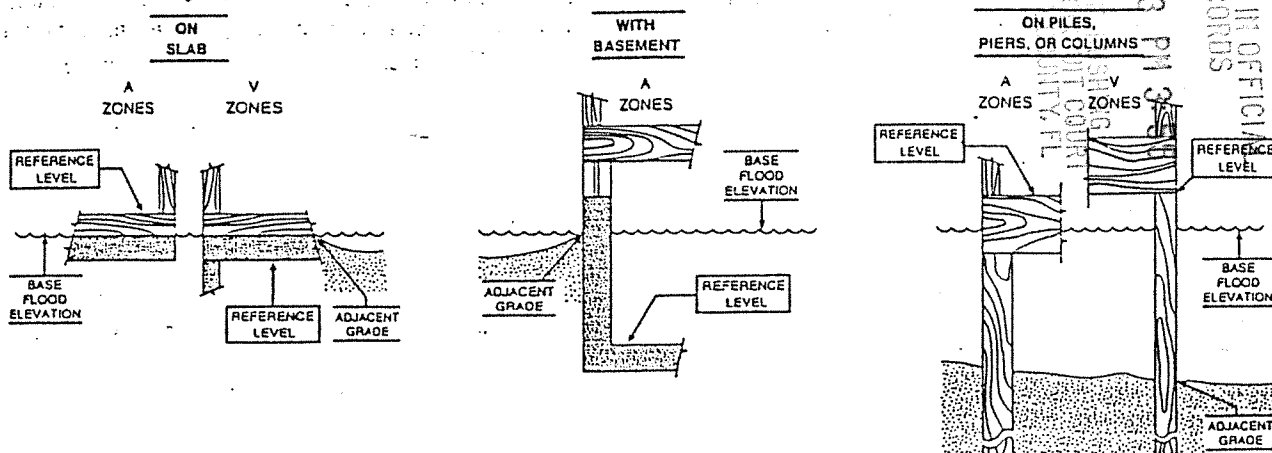
